During the In-service day on August 11th, the staff will have a zoom training with the ARC Reading company.

Principal Springer reported there are two new bus drivers that are going through the process to receive their bus permits. He plans to spread out students on school vehicles a much as possible and noted that we may need to take multiple vehicles to some events in order to make it possible. The track has been recoated and the company will repaint the lines sometime next week.
