The Board recommended contacting Lord's Inc. to obtain a price for a softener. Board member attendance at the NASB State Education Conference on November 20-22 was also discussed.

Principal Baumbach reported on the planned grades 4-6 attendance at "What The Wind Taught Me" on September 17 at the Fox Theatre in McCook commissioned by the Lied Center for Performing Arts. She also discussed upcoming activities such as "Kids on the Block", FFA Safety Day and Fitness Day. Parent-Teacher Conferences will be held on September 24 and 25 at the elementary building. Instructors will be reviewing NeSA and MAPS data scores of individual students in reading, writing, and math to examine ideas for increasing student performance. Principal Baumbach and board members commented on the success of elementary student adherence to activity rules.
