Board of Education Meeting Southwest Public Schools District 179 December 15, 2025

Matt Springer, junior-senior high school principal, arrived at the meeting at 6:15 p.m.

Moved by Teter, seconded by O'Dea, to approve a one-year agreement with a 4% salary increase with Drew Billeter as superintendent for the 2026-2027 year. Ayes: O'Dea, Neseth, Teter, Meyers and McConville. Nays: None. Absent: Brooks. Motion carried.

The board discussed a revised quote from Coach Masters in the amount of \$194,000.00 and a quote from BusesForSale.com for a 2013 MCI located in Providence, Maryland. The vendor would replace all seats and upgrade the interior for an additional \$11,500.00, bringing the final cost to \$139,250.00. Superintendent Billeter proposed sending a representative of the district to inspect the bus in person before making a down payment for the seat and interior upgrade. If the bus meets the inspection standards, two drivers would be flown to Maryland to drive the bus back to Bartley.

Moved by Neseth, seconded by Teter, to approve the purchase of a used coach bus not to exceed \$150,000.00 payable from the depreciation fund. Ayes: O'Dea, Neseth, Teter, Meyers and McConville. Nays: None. Absent: Brooks. Motion carried.

Superintendent Billeter discussed the school board general election in 2026 with three openings being placed on the ballot and discussion of an upcoming Board Policy addressing chronic student absenteeism.

Principal Springer reported on the 2024-2025 State of Schools report with major emphasis on absenteeism and the addition of a 9th period at the junior-senior high school for second semester students on the ineligibility list. He and Cris Charley discussed projects for completion during the two-week Christmas break.

Principal Fries also reported on the State of Schools report. The elementary school is enrolled in a math pilot program. She also discussed the pre-kindergarten enrollment for 2026-2027.

Moved by O'Dea, seconded by Teter, to adjourn the meeting at 6:43 p.m. Ayes: O'Dea, McConville, Meyers, Neseth, and Teter. Nays: None. Absent: Brooks. Motion carried.
