Superintendent Billeter reported on the new Coach Bus. The bus made a safe arrival and is in great condition, apart from a rim that needs replaced, repairs are currently being made. Decals for the bus are being designed and decided on. The Booster Club is generously donating new wall mats for the High School gym. The old wall mats will be removed and installed in the Old Gym. Billeter also reported on an additional Booster Club donation for "Southwest" window clings that will cover the Elementary School main door entrance. Additionally, Billeter would like to look at a solution on updating the Old Gym windows.

Billeter reported for Principal Springer on the 9<sup>th</sup> Period Study Hall being implemented at the Jr/Sr High School. This study hall is designed to provide support for students who are failing classes. Students with failing grades will be required to stay at the Highschool from 3:35pm to 4:00pm to work on any assignments needed to improve their grade, thus avoiding the Eligibility List.

Principal Fries reported on several updates for the Elementary. Winter MAPS testing will begin for all Elementary Students. A new HMH Math Supplement and Intervention Pilot Program will be implemented to assist in student improving their math skills. The program is based off each student's MAPS scores and will customize a program tailored to their specific needs. Fries encourages all parents and students to attend the Family Math Night that will take place on January 22<sup>nd</sup> at the Elementary.
