Superintendent Billeter reported on the Bank Donation Options. Stockmen's Bank and Adams Bank would like to generously give the school \$20,000 each for a total of \$40,000. Suggestions for use of the funds would be new scoreboards, wall mats, or a video board. Video board could be used for programs, graduation, and to highlight sponsors/banks/etc.

Colonial Life Term Life Insurance for Southwest Staff could be available for all Employee's that average 20 hours a week. Each employee would be eligible for \$10,000 worth of life insurance coverage for \$2 a month. Billeter suggested the school would cover that cost, assuming 75 employees would be eligible, the total would be around \$1800 a year.

Principal Tara Fries said summer school is in full swing. Fries would like to revisit the Preschool acceptance guidelines. If a preschooler has siblings in older grades that have attended Southwest Public Schools, they would possibly be accepted into Preschool regardless of numbers.
